

- Be willing to adhere to program guidelines and case worker recommendations
- Must reside in the MCN Jurisdiction
- Must pass a drug screening

Impact of McGirt V Oklahoma

July of 2020 saw a Supreme Court Ruling that impacted the Tribes of Oklahoma. This ruling recognized the Treaty of 1866 between the state and the Tribes. It took back jurisdiction from the state of Oklahoma to allow the Prosecution of Tribal Citizens by the Tribes or federal entities.

This is a major win for the tribes of Oklahoma. This has changed how the tribes handle crimes by citizens and against citizens. This has also allowed many Tribal Citizens to erase their DOC records. Citizens released by the state of Oklahoma due to lack of jurisdiction for major crimes are being retried in federal court for their crimes. The ruling by SCOTUS has been determined to not be retroactive meaning crimes committed before July 2020 shall not be retried in federal court or dismissed by the state.

- Breathalyzer testing for Alcohol
- Initial Intake
- Random testing after inception
- Intended to encourage a sober living lifestyle
- Positive test results (In/Out patient Treatment is offered)
- Non-Compliance can result in program exit
















